**Comments:** as a parish council who can contribute to the planning application process, planning regulations prevent the parish council from influencing planning applications which have a negative impact on the carbon footprint.

**Comments:** The target of 2040 for Dorset Council to be carbon neutral and 2050 for Dorset Area to be carbon neutral is not ambitious enough, the climate emergency is just that 'an emergency' and therefore requires an immediate response. It is also noted that town and parish councils receive very little mention in the action plan when their role at the grass roots community level is imperative.

Greater consideration needs to be given to onshore and offshore wind power and tidal and wave power - Dorset Council need to lobby central government to be more favourable to these forms of renewable energy which have fewer effects on the environment than many other energy sources.

Loders Parish Council would not support energy generated by nuclear power stations - Dorset Council should lobby central government to not rely on nuclear energy as a renewable power source.

Carbon emissions from Dorset buildings account for the second highest proportion of the county's footprint – 60%. Dorset Council have not considered how they will facilitate the replacement of fossil fuels in private homes.

**Comments:** help/advice needed for owners of older/traditional homes to switch from gas and oil heating. Air source heat pumps are not suitable for older traditionally constructed stone buildings and the electrical supply infrastructure does not have the capacity to provide for full electric heating (nor electric vehicle recharging points). As already mentioned, the zero carbon targets for Dorset Council and the Dorset Area need to be accelerated. The target dates of 2040 and 2050 are not ambitious enough.

### **Comments:**

- The range of actions do not address the stated key objective of increasing low carbon food production in Dorset.
- Only 4 of the 9 actions are targeted before 2023. The pace of the proposed actions should reflect a greater sense of urgency
- The action plan lacks robust targets in important areas, for example transitioning County Farms to low carbon production which aims to "Work to encourage adoption of more climate friendly practices" rather than clear, measurable and time linked targets. Same as "explore carbon reduction in procurement" – why can't there be a mandatory carbon reduction in new contracts with suppliers? And, while committing to an audit of fertiliser use in county land holdings there is no clear target associated with its reduction -- instead an undertaking to "Revise policy as required"!
- As already mentioned, the carbon zero targets for Dorset Council and the Dorset Area need to be accelerated. The zero carbon target dates of 2040 and 2050 are not ambitious enough.
- This section of the Strategy would have benefited by a greater understanding of the issues and working more closely with a range of specialist organisations
- Why no consideration of potential roles for Town and Parish Councils in meeting these targets?

Economic growth contributes to climate change - you can't have economic growth without it having a negative impact on the environment. Dorset is a major tourist destination (tourism generates traffic which is a major contributor to carbon emissions) and yet the action plan has no detail on what steps the Council will take to support it becoming a low carbon tourist destination. Also, what is meant by Eco-Tourism and how to promote it.
